The session commenced with real world demonstrations to illustrate the physical effects of even relatively small scale explosions and fires. This was performed at the GL Noble Denton facility which provides testing of components for the oil and gas industry under live conditions.

During the two days the group witnessed, and indeed physically felt the effects of events such as pipe fractures, diesel pool fires, gas explosions and jet fires.

This was followed by classroom based sessions to look at the practical lessons that can be learned from events such as the Texas City Refinery disaster, and concluded with the definition of an action plan to further increase focus in KPO on industrial safety

26 participants representing the non-commercial organisations in the social area took part in the workshop. In the course of the training the participants acquired some knowledge on the following aspects:

The training involved primarily those non-commercial organisations which over a number of previous years have sponsorship assistance KPO to implement their

social programmes and projects in the area of education, health, social welfare, art and culture. Such organisations contribute to resolving the social issues, working directly with Burlin District residents who are the strategic partners of KPO.

KPO Sustainability Department and Community Relations Section made the initial needs assessment review through interviews held

with the NCOs. The training was also attended by KPO Community Relations staff that has been cooperating with the mentioned NCOs since long time.

The training took two days and involved an experienced trainer, who used some interactive methods to make the training lively and interesting. All participants noted the benefits and importance of such workshops.

KPO held public hearings on 2013 Environment Protective Measures

In the middle of September KPO held public hearings at WKO Akimat office related to the 2013 Environment Protective Measures Plan

The 2013 Environmental Protective Measure Plan consists of 10 main sections and has 38 actions.

Representatives from the Oblast Environment Department, as well as the Members of the District Maslikhat, representatives of the Burlin Akimat and Karachaganak Field adjacent villages, members of initiative activist groups, community and mass media representatives

took part in the hearings.
Since beginning of operatorship over the Karachaganak field, from 1998 to July 2012, KPO have invested its own funds for implementation of environmental protective measures .in total amount of 32, 5 billion

tenge.
At the hearings, the KPO representatives presented both qualitative and quantitative estimated emission figures. the attendees have been provided with information on which degree the emissions

might affect the major aspects of the environment such as air, subsurface waters. soil, flora and fauna.

Successful implementation activities aimed to air protection allowed significant reduction of volumes of pollutant emissions into the air generated as result of hydrocarbons production, including the following: pollutant emissions reduced by 51% during 2006 - 2011, specific emissions reduced by 65% (per 1 million m3 of gas produced), gas utilization reached 99.92% Furthermore, 53 ha of lands contaminated

as a result of accident on well 427 were restored up to the level of agricultural lands, more than 1000 ha of lands contaminated due to well operations and construction activities have been re-cultivated upon implementation of land resources conservation actions.

As part of activities on minimisation waste volume and its environmental impact, Company constructed the modern Eco-Centre for treatment and disposal of production and household waste. The Eco-Centre meets the international standards on



environmentally safe disposal.

More than 1 million of trees and bushes

have been planted in the area of more than 500 ha within KOGCF and SPZ area.

Total costs of environment protection

plan implementation in 2013 will reach 7.1 billion KZ tenge.

KPO representatives noted that water resources conservation, wastes management and consumption, also air protection are the key priorities.

In the follow-up discussions, the community, government authorities and mass media representatives had an opportunity to ask questions about 2013 KPO Environment Protective Measures Plan and to make their suggestions and remarks. All of them will be included into the final Minutes of the public hearings. As a whole, the 2013 Environment Protective Measures Plan received the public's approval.

Throughout 2011 KPO has continued the implementation of an annual HSE Plan focusing on leadership, contractor management, hazard awareness and risk control, monitoring and review, and road safety. In 2011, KPO greenhouse gas emissions decreased from 83.9 to 83.5 tonnes of CO2 per one kilo tonne of hydrocarbons produced. Flaring reduction remained a key area with only 0.08 per cent of the total gas flared. Overall gas utilisation achieved by KPO in 2011 made up 99.92%, which is a world-class performance

Last year, KPO successfully extended certifications for the Occupational Health and Safety Management System and Environmental Management System against the OHSAS 18001 and ISO 14001 standards.

Implementation of the KPO ten-year Nationalisation Plan has continued. Last year, national employees of KPO filled 100 per cent of skilled and clerical positions, 95 per cent of

professional and supervisory and 69 per cent of manageria

positions.

Other projects included construction of the heating networks in Uralsk, construction of water pineline Aksai-Akbulak, reconstruction of the Boiler house in Aksai micro-district #10, a school

in Priuralnoye village as well as construction of music school in Zhympity village.
