On 2 October Kazakhstan President Nursultan Nazarbayev and Eni CEO Paolo Scaroni met in Astana for the VII Kazernergy Eurasian Forum.

During the meeting, which was cordial and constructive, Eni's CEO shared the developments and results of the company's ongoing activities in the country with the President, affirming Eni's positive vision of the primary importance projects that Kazakhstan presents, such as the Kashagan and Karachaganak.

Futhermore, Eni's CEO informed President Nazarbayev on the progress of the agreement of cooperation and mutual understanding, originally signed by National Company KazMunaiGaz and Eni in 2009, for the implementation of investments in Kazakstan's industrial infrastructure.

The President was also informed of joint projects for building a shipyard in the





Caspian Sea and a gas turbine power plant in West Kazakhstan region.

Eni has been present in Kazakhstan since 1992, where the company co-operates the Karachaganak producing field and is a partner of the North Caspian Sea PSA consortium to develop the Kashagan field and is involved in the North Caspian Sea PSA project to develop the Kashagan field.

On 12 September in Astana, Damiano Ratti attended a session of the RoK Council for the Improvement of Investment Climate chaired by the Prime Minister Karim Massimov. During the speeches and the follow-up discussions the parties exchanged views on the most pressing issues of environmental governance in Kazakhstan's oil and gas industry and the ways of resolving those. Damiano Ratti, KPO General Director, in his presentation shared about the Company's achievements in GHG emission reduction and waste management. He also made several practical proposals for the improvement of the current regulatory system and the way the companies' environmental performance is evaluated.

In conclusion of this very productive meeting, it was agreed that the parties should continue the dialogue and join their efforts in this direction

KPO launched new schools in WKO

On the eve of the Constitution Day of Kazakhstan and the new school year, KPO successfully completed the construction of several secondary schools in the Western Kazakhstan Oblast.

As part of its social infrastructure development programme, constructed three new schools: one in Uralsk town and two schools in the remote villages of Aksuat in Akzhaik District and Ushagash in Karatobe District. In addition, KPO has completed a major refurbishment of the secondary school in Uspenovka village in Burlin District. The total KPO investments into these projects have exceeded \$16

million.
On this occasion, KPO General Director, Damiano Ratti, said, "We are proud that children of Western Kazakhstan will now be able to receive quality education in these modern schools. Their construction was agreed with the WKO Akimat in accordance with the RoK State Programme "100 schools, 100 hospitals". All schools have been fully equipped with computer classes, are connected to Internet, and are being handed over on a turn-key basis. We hope these new schools will help bring the standards of education in the region to a new

"KPO is committed to a sustainable future and allocates \$20 million per annum for social infrastructure development the region. Operating as a responsible corporate citizen, RPO is working towards achieving sustained success to the benefit of the local communities and the Republic of Kazakhstan as a whole", added Damiano

As it is known, the KPO social programme is primarily focused on health, education, culture and

sporting facilities, according to the priorities set by the Western Kazakhstan Oblast authorities. As a result of this partnership, significant number of new schools and kindergartens have been constructed in the region, as well as hospitals, roads and public utilities. All KPO social projects have been implemented using only Kazakh companies and vendors.

The school for 1200 pupils in Uralsk consists of five blocks, equipped with a lift, a canteen, an infirmary, a conference room, a gymnasium, an amenity block and a library. The school has been fully furnished and equipped with all necessary equipment. The construction was implemented by a local contractor Zhaikselstroy, LLP within one

Thanks to the new school for 230 pupils. the children of Aksuat village in Akzhaik District will now be able to receive same quality of secondary education as in a town.

KPO contracted a local Bolashak-T, LLP company to construct the school.

Uralskstroyinvest, LLP, has constructed the school for 108 pupils in Ushagash village of Karatobe District. The two-storey school has classes, a gymnasium, conference room, canteen and a library. The classrooms have been fully furnished and equipped to high standards

Two other schools for 198 pupils in Koneketken village in Terekty District and Saikuduk village in Akzhaik District are currently nearing completion as part of the KPO social programme.

Over the recent years, KPO has also



completed refurbishment of rural schools in Dimitrovo and Karachaganak villages. In 2010, KPO donated new buses for six rural schools

In addition, this year, KPO has sponsored summer holidays for more than 160 children from a number of Burlin District villages situated around the Karachaganak field.

KPO promotes safety culture amongst the Aksai schoolchildren

On 1st September KPO representatives visited the local studio of "Aksai Radio" where they spoke about the Road Safety Programme initiated and launched by KPO on the radio in July this year.

KPO was represented by Gaziz Khassanov, Infrastructure and Services HSE Manager, Mira Berdigaliyeva, HSE Management System Documentation Specialist, Irina Cherkassova, Deputy Safety Manager and Cristiano Gioacchini, HSEQ Controller. During the radio interview they told about the main objectives of the programme and future plans of the Company on safety rules training for schoolchildren.

Schoolchildren also took part in the airplay and answered questions on the Road Safety uiz. The winners of the final program were awarded with prizes from KPO.

The main purpose of the Road Safety Programme is training of schoolchildren on the road safety rules. During the project schoolchildren have learnt about the key road safety rules, in particular for cycling, roller skating, motorbike and scooter driving.

This educational program is of great interest for junior audience, and during its existence

some 100 Aksai students have trained in been road safety. As noted by Cristiano the Gioacchini, Safety Road Program was initiated by KPO for a reason safety of both employees and their families is one of the top priorities for the Company. Given the fact that children are often at risk on the



roads, it is important to teach them from an early age to behave safely on the roads.

It should be noted that KPO has been actively promoting the road safety training program for schoolchildren on the Aksai Radio since 2007. Some of the training programs included such as 'Traffic Light', 'In word and deed', were also put on the air on the Aksai Radio. According to Gaziz Khassanov, such projects will be continued in the future, for instance, the safety program is currently planned to run at schools in Aksai.

KPO attends Technology and R&D Roadmap Workshop in Astana

Kussanov (Permits and Licenses Manager), Simon Coley (Senior Field Production Engineer), and Ato Aidoo (Senior Planning and Performance Engineer) have recently attended Technology and R&D Roadmap Workshop for upstream oil and gas in Kazakhstan which took place in Astana. The workshop was the third stage in a

process that started in 2010. During 2010, in accordance with the proposal sounded at the Foreign Investment Council (FIC) meeting #22 and the order by the Prime Minister pursuant to the Protocol of the session paragraph 5.5.1.2 dated as of December 4th, 2009, № 01-8.2, a «Technology mapping exercise for the oil and gas sector of Kazakhstan» was initiated and has to date been led by Shell, with participation from other operating companies (both international and local), including KPO b.v.

Based on the protocol issued by the Prime Minister in 2010, a challenge was issued by the President of Kazakhstan, His Excellency Nursultan Nazarbayev, to the oil and gas industry with a vision to "To create an effective environment for R&D development through policies and procedures facilitating the collaboration between universities and industry; to facilitate local capacity building in the area of technology development for the RoK oil and gas sector."

With the vision, set by the President, the mission to set up a R&D STRATEGY MAPPING INITIATIVE to achieve it was initiated with the support of representatives of the Kazakh Institute of Oil and Gas (KING), KazMunaiGas (KMG) and the International oil companies (IOCs), to successfully accomplish the assigned tasks. This mission aims to assist the government of Kazakhstan in facilitating the technology prioritization process based on mid- to long-term oil and gas industry needs; to provide guidance in establishing enabled framework for collaboration between industry and the state. The main objectives of the roadmap can be summarised as follow:

To formulate an Upstream Oil & Gas sector industry view on the required Capacity Building considering:

- Challenges Technology Challenges facing Kazakhstan fields in the next 15 years and
- potential Solutions to meet these
 Focus Areas for R&D in Kazakhstan
 Opportunities for the local industry to develop and provide the solutions
- Focus areas for education to develop a
- workforce with the required skills
- Strategic Initiatives that will enable:
 o Increased effectiveness of the R&D and greater involvement with the Oil & Gas
- o Development of the local industry to
 - Suggested measures that Kazakhstan

Government could take to stimulate the R&D and the development of the local industry

In April 2011, the report from road mapping itiative identified five (5) Technology Target Areas (TTAs) and Technology Challenges as focus areas for development of the roadmap. The main TTAs identified for Kazakhstan

- Reservoir Characterisation
- Field EquipmentFluid Flow and Processing
- · Wells and Field Management
- HSF

The roadmap team in order to achieve the objectives performed a Research & Development assessment on the current state of R&D in Kazakhstan. Operator representatives, from various IOC's as well as LOC's, jointly assessed the current capabilities of the identified/selected R&D facilities in Kazakhstan across the five (5) Technology Target Areas (TTAs). They aimed to identify opportunities for increased Research collaboration between Operators and R&D facilities and to identify potential initiatives to build R&D capabilities in Kazakhstan over the next 10 years.

Technology Assessment forms a key part of the Roadmap. The diagram below shows

the stages for design of the roadmap:
The process has involved a review of existing roadmaps developed in other countries including Norway, Brazil, Australia and others. The process has also involved visits to identified R&D institutions, centres, universities and specified local companies in major cities in Kazakhstan including Almaty, Aktau and Atyrau in March and April 2012, after receipt and review of responses to questionnaires previously sent to them. At these visits clarifications were sought on relevant areas on the responses to the questionnaires. KPO was represented at the visits to Aktau and Atyrau, in April 2012, by Simon Coley and Ato Aidoo, who participated in the technical assessment

process for the institutions and companies visited in both cities.

The June 2012 workshop was organised in continuation of the process. The aim was for participants to review the results of the previous stages of the roadmap for each TTA and to identify "quick wins" (opportunities): prioritise research collaboration opportunities between Operators and R&D facilities Priorities for R&D focus for Oil & Gas in Kazakhstan over the next 10 years. The event which was coordinated by Shell Global Solutions International B.V. brought together 146 participants representing government agencies, oil companies, supply companies, consultants, engineering contractors, consultants, universities, and other institutions of RoK.

During the workshop Zhardem Kussanov participated in TTA-1 on Reservoir Characterisation which addressed:

- Seismic Data Acquisition Processing
- Reservoir Description (Geology, Rock & Fluid Interpretation)
 - Well Logging and In-Well Monitoring
 Core and Data Analysis
 - Fluid Property Analysis

Simon Coley participated in TTA-2 on

- Field Equipment covering:

 Equipment and Materials for Sour Operating in Ice/Cold Climate
- Management of Sulphur
 And Ato Aidoo participated in TTA-4 on
 Wells & Field Management covering:
- Drilling and Well Costs
 Field Management: Optimise Recovery including IOR/EOR

For each TTA, a general goal was set to achieve the roadmap objectives. Stepwise (staircase) progression for capacity building and development of the respective focus areas was discussed between participants and timeline with milestones in the years 2015; 2020 and 2025 were set.

The roadmap plan is to have the

initiative mapping process completed by year end in 2012. The remaining targets The remaining targets left for completion before the end of the year

- · Review of the report resulting from the June 2012 workshop by the Kazakhstan Government. This will help the Government to prioritise on the R&D development areas and to steer capacity building in those areas for future development.
- A strategy workshop will be held to firm the timeline for implementation of the roadmap. That is expected to be help in September 2012.
